- Other Expenditure in the current period include Trademark License Fees and other overheads.
- Increase in Depreciation charge is on account of revaluation of depreciable assets in the last year.
- Tax Expense include Minimum Alternative Tax and fringe benefit tax. Deferred Tax Assets / Liabilities will be considered in Annual Accounts.
- Figures for previous period have been reclassified to conform to the figures of the current period.
- Proceeds of Rights Issue made in February 2008 are utilised for objects stated.
- A Limited Review of the above Financial Statement has been carried out by the Statutory Auditors. With regard to Auditors Remark, on presentation on contract cost, the procedure has been consistently followed and in line with Industry practice. However, it does not have any impact on above financial results.
- The above financial results have been reviewed by the Audit Committee and approved by the Board of Directors at it's meeting held on 27th July 2009.
- One Investor complaint received during the quarter was resolved. There were no pending complaints either at the beginning or at the end of the Quarter.
